**Notification of RSPO Re-Certification of Betung POM – PT Laguna Mandiri subsidiary of Sime Darby Plantation Berhad (RSPO membership number 1-0008-04-000-00, 06 September 2004)**

Dear Stakeholders,

Sime Darby Plantation Berhad has applied to PT Mutuagung Lestari for RSPO Re-Certification to Betung POM and its supply bases, located in Village of Betung, Sub District of Pamukan Utara, District of Kotabaru, Province of Kalimantan Selatan, Indonesia against the requirement of Standard Indonesian National Interpretation of RSPO Principles and Criteria 2013 by INA-NITF, July 2016 (Endorsed by the RSPO Board of Governors meeting on 30<sup>th</sup> September 2016) and Supply Chain Requirement for CPO Mill, November 2014 revised on 14 June 2017.

PT Laguna Mandiri has been taking an active role in the RSPO certification processes and implementing programmed to continue RSPO certificate. PT Laguna Mandiri has been registered in PalmTrace IT Platform with member ID RSPO\_PO1000000323. PT Mutuagung Lestari has arranged to conduct the Re-Certification of PT Laguna Mandiri which has 1 (one) mill and 2 (two) estates on **11 to 15 March 2019**.

As a private national company and supported with highly committed professionals, MUTU has gained recognition nationally and internationally. Since June 2003, MUTU has received recognition from the Ministry of Agriculture, Forestry, and Fishery of Japan (MAFF) as registered overseas certification body (ROCB). MUTU certify and mark products with Japan agriculture standard (JAS) covering Indonesia, Myanmar, Cambodia, Malaysia, Vietnam, Timor Leste, Philippines, Papua New Guinea and China. MUTU is the first ROCB in Asia. National Accreditation Committee has accredited MUTU as Quality Management System certification body (ISO 9001:2015) and Environmental Management System
