**Sime Darby Plantation Sdn Bhd**, RSPO Membership number: 1-0008-04-000-00, has applied to PT SGS Indonesia to conduct RSPO P&C Re-Certification assessment for one of Strategic Operating Unit (SOU) Labu which hold valid RSPO Certificate number 824 502 16039, valid thru 29 December 2016.

The Certification Assessment scope is Labu Palm Oil Mill and its supply base, located in Labu, Negeri Sembilan – Malaysia against the requirement of the Roundtable on Sustainable Palm Oil, Principles and Criteria (RSPO P&C) MY-NI 2014 and the RSPO Supply Chain Certification Systems (SCCS) 2014 for Palm Oil Mill – Module D: Identity Preserved.

The organization is a member of RSPO and has been taking an active role in the RSPO certification processes and planned to achieve RSPO Sustainable Palm Oil requirement for all of its production. 
